Automating Redaction - Sample PDF

This sample contains four W4 tax form for new employees at the "My Widgets" company. Certain text on the forms needs to be redacted, or removed, before the forms can be distributed to other departments. Two different redactions need to be done for two different distributions.

Because redaction is a privileged operation the redaction code needs to be run from either a trusted automation script, or the Acrobat JavaScript Console. Click on the button below to copy the redaction code to the console window.

Redaction is a 3 step process, so the redaction script is divided into 3 parts. After copying the code to the console window. Select and execute Step1 and Step2 to perform basic setup. Then select code for one of the two options in Step3 and then run this code to perform the actual redaction.
